

**Subject:- Transfer/Withdrawal of Court Cases in District Kathua.**

**ORDER NO: 949/FC-AP**

**DATED: 09.02.2023**

While examining the pendency of cases in Revenue Courts of UT of J&K through RCCMS, it has come to fore that large number of cases are pending disposal in the court of Additional Deputy Commissioner (Headquarters), Kathua. This has led to delay in disposal and inconvenience to the general public.

In order to expedite the disposal of court cases and in the interest of general public, exercising powers under sections 8, 9 and 10 of J&K Land Revenue Act, Svt. 1996 and section 19(2) of J&K Agrarian Reforms Act, 1976, it is hereby order that:-

- i. The cases mentioned in the annexure-I to this order (numbering 54) pertaining to Sub Division Bani are transferred to Additional Deputy Commissioner Basohli, who shall hear the cases at Basohli. This is as per S.O. 587 dated 10<sup>th</sup> November 2022. On the already notified date, these cases shall be heard by the ADC Kathua at the District Headquarters & on that day, the parties shall be directed to cause their appearance before the Court of ADC Basohli on a date to be clearly mentioned in the order sheet so that the parties are not required to be served afresh. The date to be indicated shall not be later than two weeks, within which time the court file shall be transferred to the new court. On the date of transfer, the transfer shall also be effected on the RCCMS necessarily.
- ii. The cases mentioned in the annexure-II to this order (numbering 122) are transferred to Additional Deputy Commissioner Basohli with the direction that the said ADC shall hear the cases at Kathua District Headquarters. The first hearing of a case by ADC Basohli at District Headquarters shall be on the already notified date by

the court of ADC Kathua, as also mentioned in this order. However, subsequent dates shall be assigned by the Presiding Officer such that a given case is listed, if not twice, at least once in a month. The ADC Basohli shall hold the court at District Headquarters at least five days in a month.

- iii. Fresh Cases pertaining to the jurisdiction of Additional Deputy Commissioner Kathua shall continue to be instituted before ADC Kathua (Headquarters).
- iv. The Deputy Commissioner Kathua shall make necessary arrangement to enable the ADC Basohli to hold court at District Headquarters. He shall also assign Reader and other supporting staff at the District Headquarters for the said purpose; these officials shall not be assigned any additional charges.
- v. A report regarding monthly disposal of cases shall be submitted by both the ADCs to this office by or before 5<sup>th</sup> of every month.
