Sanction is hereby accorded to the temporary appointment of Sh. Nikhil Kumar S/o Late Sh. Som Nath R/o Village Deeli, Tehsil Jammu South, District Jammu as MTS(Class-IV) in the pay level of SL-1(14800-47100) against an available vacancy in Revenue Department in District Cadre Jammu in terms of provisions of SRO-43 of 1994.

The appointee shall report to Deputy Commissioner, Jammu within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join after the production of following documents/certificates (in original) to be verified subsequently:-

- (i) Academic qualification(s) certificate.
- (ii) Matriculation/Date of Birth Certificate.
- (iii) Domicile Certificate issued by the competent authority.
- (iv) Health Certificate from the concerned Chief Medical Officer of the District.
- (v) Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- (vi) Dependent Certificate issued by the designated authority.
- (vii) All other relevant documents as are required under SRO-43/1994.

The appointment of the above candidate shall further be subject to the following conditions:-

a. That if the appointee has taken loan for self employment from DIC/employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile district, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the appointee regarding both relinquishment of proprietorship and stakes if any, in such a self-employment unit/enterprise and recovery to be made and shall also personally monitor its recovery.

- b. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him.
- c. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of Qualification/Date of Birth is received from the concerned authorities.
- d. The appointee(s) shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Services (CCA) Rules, 1956.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed have been cancelled *ab-initio*, without any further notice.
