Subject: Submission of arrears i.e. 7<sup>th</sup> pay Commission and Salary arrears.

**CIRCULAR**

There are various pending arrear claims that the office of Financial Commissioner (Rev) is in receipt every day, often without sufficient detail and /or justification. This practice of allowing arrears to remain unattended for long periods of time reflects adversely upon the DDOs and requires to be addressed suitably. Finance Department has already issued a circular for settlement of Time Barred Claims vide No. A/23(08)-I-B-184 dated: 18-02-2021 and subsequent Clarification regarding "payment of time barred arrear claims presented at Treasuries" vide No. DGAT/PS/15/2021-05-309 dated: 24-12-2021.

However, there is large pendency in the Revenue Department which still needs consideration.

In order to streamline the matter and estimate the liability a format stands devised and is indicated below:

Also, it is to be certified that the information submitted is complete in all aspects and correct as per record and there is no employee left pensionable/or employees under NPS whose salary related requirement and any other arrears is pending till date and the requirement has to be included in the projected amount.

After the first report reflecting all previous liabilities, a quarterly report shall be furnished by the DDO's. The first report should be furnished by 31<sup>st</sup> August, 2022 on jkfinancialcr@gmail.com.
