**Subject:-Acceptance of Resignation of Sh. Vishal Bhat, MTS – Discharge thereof.**

**ORDER NO:- 178-FC(Adm) of 2024**

**Whereas,** Sh. Vishal Bhat was appointed as MTS in the Revenue Department under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits, in District Cadre, Anantnag, vide Government Order No.98 JK-Rev of 2022 dated 09.05.2022; and

**Whereas,** as per his service records, Sh. Vishal Bhat joined as MTS in the office of Deputy Commissioner, Anantnag on 11.05.2022.

**Whereas,** Sh. Vishal Bhat has tendered his resignation in the office of Deputy Commissioner, Anantnag w.e.f. 04.03.2024, on the grounds that he has been appointed as Junior Assistant in Department of School Education, Kashmir vide Order no. 60-DSEK of 2024 dated 26.02.2024; and

**Whereas,** Divisional Commissioner, Kashmir vide letter no. DivCom/E-7471192/Estt/984 dated 25.06.2024, forwarded the resignation of Sh. Vishal Bhat, MTS to this office for further necessary action; and

**Whereas,** the matter has been considered with reference to the rules governing the subject and it has been found that the above said official is still on probation and has not qualified the prescribed service for confirmation of probation, on account of which, he is liable to be discharged from the service by terminating his probation in terms of Rule 21(1)(b) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956, on his own request.

**Now therefore,** in exercise of the powers conferred under Rule 21(1)(b) of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 the probation of Sh. Vishal Bhat S/o Karan Kumar R/o Lok Bhawan Anantnag, Dooru, District Anantnag, MTS appointee under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits, is hereby terminated and accordingly he is discharged from the Government Service with effect from 04.03.2024 i.e. date of his resignation, on his own request.
