Whereas, the Jammu and Kashmir Services Selection Board, J&K has forwarded selection list of candidates for the post of Patwari (District-wise) of Revenue Department advertised vide Advertisement Notice No. 6 of 2015; and

Whereas, the Revenue Department forwarded these Selection lists to this office vide letter No. Rev/NG/30/2019 dated 26.02.2019, Rev/NG/20/2019 dated 28.02.2019, Rev/NG/25/2019-I dated 26.02.2019, Rev/NG/25/2019-I dated 24.04.2019, with the request to issue formal appointment order within the stipulated period after fulfilling of all requisite formalities; and

Whereas, in pursuance of Government Order No. 1328-GAD of 2016 dated 07.12.2016, a notice was issued vide this office No. FC(Adm-PTW)04/2019 dated 08.03.2019, No. FC(Adm-PTW)04/2019 dated 12.03.2019 and No FC(Adm-PTW)04/2019 dated 10.04.2019 informing all the selected candidates to report in this office within a period of 21 days from the date of publication of this Notice alongwith requisite documents annexed with the said Govt. Order duly filled in, so that the formal appointment order is issued by this Office; and

4. Whereas, a second notice was issued vide this office No. FC(Adm-PTW)04/2019 dated 10.04.2019 and final notice was issued vide this office No. FC(Adm-PTW)04/2019 dated 11.06.2019; and

5.
