**Subject: Compassionate appointment case of Mohammad Iqbal Lone S/o Late Habibullah Lone R/o Krusan Tehsil Lalpora District Kupwara as Orderly under SRO-43 of 1994.**

In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22/02/1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of **Mohammad Iqbal Lone S/o Late Habibullah Lone R/o Krusan Tehsil Lalpora District Kupwara as Orderly in the pay band of Rs. 4,440 – 7,440 + Grade pay Rs 1,300/- (pre-revised) SL1 14800 (revised)**, under **SRO-43 of 1994** against an available vacancy in Revenue Department, in District Kupwara.

The appointee shall report to Deputy Commissioner, Kupwara within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates to be verified subsequently:-

1. Academic qualification certificate.
2. Date of Birth certificate.
3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.

The appointee shall be initially on probation for a period of two years, and if, on verification, the certificate produced by the appointee are proved to be fake or forged, the appointment shall stand cancelled ab-initio in terms of General Administration Department circular No. 17-GAD of 2012 dated 07/6/2012.

Further, the salary of the appointee shall not be drawn and disbursed to the appointee unless verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner, Kupwara. Appointee shall furnish an affidavit to the effect that in case of any adverse report about his character and antecedents, he shall have no right to claim the appointment as Orderly in Revenue Department, District Cadre Doda and his appointment shall be deemed to have been cancelled ab-initio.
