Subject: Cancellation of appointment of Naib Tehsildar in Revenue Department (State cadre).

Order No. 228 FC (Revenue) of 2021  
Dated: 22/2 - 02 - 2021

Whereas, the recommendations of J&K Services Selection Board furnished vide No. SSB/Secy/Sel/S/18/2020/2417-23 dated 16.03.2020 and No. SSB/Secy/Sel/ S/18/2020/2930-32 dated 14.08.2020 for 153 posts of Naib Tehsildars (State Cadre) were received from the Revenue Department vide No. Rev/NG/73/2019 dated 27.04.2020 for issuance of appointment orders; and

Whereas, on the basis of above recommendations of J&K SSB, vide Order No. 102-FC(Revenue) of 2020 dated 15.5.2020; Order No. 106-FC(Revenue) of 2020 dated 5.6.2020, Order No. 112-FC(Revenue) of 2020 dated 19.6.2020; Order No. 128-FC(Revenue) of 2020 dated 15.7.2020, Order No. 130-FC(Revenue) of 2020 dated 31.7.2020, Order No. 150-FC(Revenue) of 2020 dated 24.8.2020, Order No. 203-FC(Revenue) of 2020 dated 23.12.2020, 153 candidates have been appointed as Naib Tehsildars; and

Whereas, due to non-joining of nine candidates comprising of 06 OM, 02 ALC and 01 RBA categories within the stipulated period of 21 days, their appointment as Naib Tehsildar (State cadre) was cancelled ab initio vide Order No. 140-FC(Revenue) of 2020 dated 14.8.2020; and

Whereas, on the request of this department, the Administrative Department vide letter No. Rev/NG/73/2020 dated 24.12.2020 authorized to operate the waiting list already recommended by J&K SSB vide above referred communications, for appointment of 09 candidates of the respective categories as Naib Tehsildars; and

Whereas, formal appointment order in favour of 09 candidates figuring in the wait lists of OM (06), ALC (02) and RBA (01) categories was issued vide Order No.205-FC(Revenue) of 2020 dated 28.12.2020 with the direction to report to the office of Principal Revenue Training Institute, Jammu/Kashmir as the case may be, within a period of 21 days; and

Whereas, General Administration Department vide Circular No.14-JK(GAD) of 2020 dated: 17.06.2020, advised all departments for inclusion of standard condition of automatic cancellation of appointment in the appointment orders which is reproduced hereunder:

*"The candidates who fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice"*

Whereas, the Principal, Revenue Training Institute, Jammu vide No. RTI/JMU.2020-21/733 dated 18.01.2021 has intimated that Ms. Sofia Akhter D/o Shri Gulzar Mohd. R/o Gujjar Nagar Jammu (OM at S.No. 05 in the said order) has not joined within the stipulated period of 21 days; and

Whereas, since the candidate has failed to join within the stipulated period of 21 days, she foregoes her right of appointment, in terms of the conditions laid down in her appointment order without any further notice.

Now, therefore, in view of the above, the appointment of Ms. Sofia Akhter D/o Shri Gulzar Mohd. R/o Gujjar Nagar Jammu made, interalia, vide Order No.205-FC(Revenue) of 2020 dated 28.12.2020 as OM candidate at S.No.05 as Naib Tehsildar (State Cadre) in the Revenue Department is hereby cancelled abinitio.
