**Subject:- Acceptance of Resignation of Sh. Pankaj Kumar– Discharge thereof.**

**Whereas**, Sh. Pankaj Kumar was appointed as Jr. Assistant in the Revenue Department in District Cadre, Baramulla, vide this office Order No.259 FC(Rev) of 2023 dated 02.06.2023; and

**Whereas**, as per his service records, Sh. Pankaj Kumar, joined as Jr. Assistant in the office of Deputy Commissioner, Baramulla on 06.06.2023.

**Whereas**, Sh. Pankaj Kumar has tendered his resignation in the office of Tehsildar Boniyar w.e.f. 05.02.2024 on the grounds that he has been appointed as Sub Inspector in the Home Department vide Order No. 481 of 2024 dated 20.02.2024. Tehsildar Boniyar vide letter no.Teh/Byr/N/24/23 dated 01.05.2024 forwarded his resignation to the Deputy Commissioner, Baramulla who vide letter no. DCB/N/2024-25/244-45 dated 28.05.2024 forwarded his resignation to the office of Divisional Commissioner Kashmir, for consideration; and

**Whereas**, Divisional Commissioner, Kashmir forwarded the resignation of Sh. Pankaj Kumar, Jr. Assistant to this office via e-office file bearing no. DIVCOM-ADCA/3/2024-06 (7503494) for consideration; and

**Whereas**, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official is still on probation and has not qualified the prescribed service for confirmation of probation, on account of which, he is liable to be discharged from the service by terminating his probation in terms of Rule 21(1)(b) of J&K Civil Services Regulations (Classification, Control and Appeal) Rules, 1956, on his own request.

**Now therefore**, in exercise of the powers conferred under Rule 21(1)(b) of J&K Civil Services Regulations (Classification, Control and Appeal) Rules, 1956 the probation of Sh. Pankaj Kumar S/o Rashpal Bhagat R/o Bhour Camp, Chatha, Tehsil Jammu South, District Jammu is hereby terminated and accordingly he is discharged from the Government Service with effect from 04.03.2024 i.e. date of his relieving, on his own request.
