Whereas, Sh. Muhammed Nadeem Shah was appointed as MTS in the Revenue Department in District Cadre, Poonch, vide Government Order No.78-JK(Rev) of 2021 dated 21.10.2021; and

Whereas, as per his service records, Sh. Muhammed Nadeem Shah, joined as MTS in the office of Deputy Commissioner, Poonch on 01.11.2021.

Whereas, Sh. Muhammed Nadeem Shah has tendered his resignation in the office of Deputy Commissioner Poonch w.e.f. 07.03.2024 on the grounds that he has been appointed as Jr. Engineer (Civil) in the Public Works (R&B) Department vide Government Order No. 61-PW(R&B) of 2024 dated 07.03.2024 Deputy Commissioner, Poonch vide letter no. DCP/Estt/323/3327-28 dated 09.03.2024 forwarded his resignation to the office of Divisional Commissioner Jammu, for consideration; and

Whereas, Divisional Commissioner, Jammu forwarded the resignation of Sh. Muhammed Nadeem Shah, MTS to this office vide letter no. 101/3764/24/1874-75 dated 03.09.2024 for consideration; and

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official has completed his probation and has qualified the prescribed service for confirmation of probation, on account of which, his resignation is liable to be accepted in terms of Rule 200 of J&K Civil Services Regulations, 1956, on his own request.

Now therefore, in exercise of the powers conferred under Rule 200 of J&K Civil Services Regulations, 1956 the resignation tendered by Sh. Muhammed Nadeem Shah S/o Sh. Anwer Shah R/o House No.97 Ward No.5 Chikri Ban, District Poonch, MTS is hereby accepted and accordingly he is discharged from the Government Service with effect from 07.03.2024 i.e. date of his resignation, on his own request.
