Whereas, as per service records, Sh. Muzafar Hamid, joined as MTS in the Office of Deputy Commissioner, Baramulla on 28.10.2021.

Whereas, Mr. Muzafar Hamid, MTS has tendered his resignation from the post of MTS, in the J&K Revenue (Subordinate) Service in District Cadre Baramulla with effect 20.06.2024 on the grounds that he intends to continue and pursue his further studies; and

Whereas, Divisional Commissioner, Kashmir vide letter no. Divcom/E-7535327-17-Misc/Estt/1660-61 dated 30.08.2024, forwarded the resignation of **Mr. Muzafar Hamid, MTS** to this office, alongwith his recommended the case for acceptance of resignation.

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official completed his probation has qualified the prescribed service for confirmation of probation, in account of which, his resignation is liable to be accepted in terms of Rule 200 of J&K Civil Service Regulations 1956 on his own request.
