Whereas, Sh. Azhar Ali was appointed as MTS in the Revenue Department under District cadre, Bandipora vide Government Order No. 118 JK(REV) of 2022 dated 13.06.2022; and

Whereas, as per his service records, Sh. Azhar Ali joined as MTS in the office of Deputy Commissioner Bandipora on 20.06.2022 and was further transferred in the office of Deputy Commissioner Anantnag by the Divisional Commissioner Kashmir; and

Whereas, Sh. Azhar Ali has tendered his resignation before the office of Deputy Commissioner, Anantnag w.e.f 09.09.2024 on the grounds that he has been appointed as Assistant Compiler in Department of Finance vide Order No. 142-DGF of 2024 dated 05.09.2024; and

Whereas, Divisional Commissioner, Kashmir vide letter no. DivCom/E-7603824/17-Misc/Estt/2386-87 dated 19.11.2024 forwarded the resignation of Sh. Azhar Ali, MTS to this office for further necessary action; and

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official has completed his probation and has qualified the prescribed service for confirmation of probation, on account of which, his resignation is liable to be accepted in terms of Rule 200 of J&K Civil Services Regulations, 1956 on his own request.

Now therefore, in exercise of the powers conferred under Rule 200 of J&K Civil Services Regulations, 1956, the resignation tendered by Sh. Azhar Ali S/o Mohd Younas R/o Anderwan Sangam Anantnag, MTS, is hereby accepted and he is discharged from the Government Service with effect from 09.09.2024 i.e. date of his resignation, on his own request.
