Subject:-Acceptance of Resignation of Sh. Mohd Abrar, Patwari – Discharge thereof.

Whereas, Sh. Mohd Abrar was appointed as Patwari in the Revenue Department under in District Cadre, Udhampur, vide Government Order No.92 Rev/NG/314 of 2013 dated 10.12.2013 read with corrigendum issued under no.Rev/NG/15/2011 dated 19.12.2013; and

Whereas, as per his service records, Sh. Mohd Abrar joined as Patwari in the office of Financial Commissioner Revenue, J&K on 16.12.2013 and was further adjusted in Office of Deputy Commissioner Udhampur vide this office Order No. FC(ADM) 253 of 2013 dated 24.12.2013; and

Whereas, Sh. Mohd Abrar has tendered his resignation from the post of Patwari in the office of Tehsildar Udhampur with effect from 23.07.2024, on the grounds that he has been appointed to the Jammu and Kashmir (Gazetted) Service vide Government Order No. 1395-JK(GAD) of 2024 dated 23.07.2024. The Tehsildar Udhampur vide letter dated 16.08.2024 forwarded his resignation to the Deputy Commissioner Udhampur, who vide letter dated 24.10.2024 forwarded the resignation to the Office of Divisional Commissioner, Jammu for consideration; and

Whereas, Divisional Commissioner, Jammu vide letter no. 101/3764/2024/2514-15 dated 30.10.2024, forwarded his resignation to this office for consideration; and

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official completed his probation and has qualified the prescribed service for confirmation of probation, on account of which, his resignation is liable to be accepted in terms of Rule 200 of J&K Civil Services Regulations, 1956, on his own request.

Now therefore, in exercise of the powers conferred under Rule 200 of J&K Civil Services Regulations, 1956, the resignation tendered by Sh. Mohd Abrar S/o Mohd Mushtaq R/o Kud, Tehsil Chenani, District Udhampur, Patwari, is hereby accepted and he is discharged from the Government Service with effect from 23.07.2024 i.e. date of his resignation, on his own request.
