As recommended by the J&K Service Selection Board, Jammu/ Srinagar and endorsed by the Administrative Department vide their letter referred to above, Mr. Shahid Ahmad Bhat S/o Mr. Nazir Ahmad Bhat R/o Syedabad Pastuna, Post Office Syedabad, Tehsil Tral, District Pulwama, is hereby appointed temporarily as Junior Assistant under RBA in the Revenue Department, District Cadre Pulwama in the pay level-4 ( Rs 25500-81100)


The candidate shall report to Deputy Commissioner, Pulwama within a period of 21 days from the date of issuance of this order and the Deputy Commissioner, Pulwama shall allow the appointee to join only on production of the following documents / certificates (in original) to be verified subsequently.

1. Academic / Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate.
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Relevant Category Certificate.

The appointment of the candidate shall further be subject to the following conditions that:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification certificate from the concerned issuing authority is found fake / forged the claim of the appointee for appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c) The appointment shall be governed by the "Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020" notified vide SO 192 of 2020 dated 17.06.2020.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e) If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- f) The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
- g) The appointment of the candidate is subject to the outcome of writ petition(s) if any, pending in any court of law on the subject.
