Sanction is hereby accorded to the temporary appointment of **Mr. Sahil Kumar S/o Late Rattan Lal (Ex-Driver) R/o Kundal, Tehsil Padder, District Kishtwar** as orderly in the pay level of SL-1 (14800-47100) against an available vacancy in (UT Cadre) in the office of Financial Commissioner (Rev) J&K, in terms of Provisions of SRO-43 of 1994.

The appointee shall report in the Office of Financial Commissioner (Rev) J&K, within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join after the production of following documents/certificates (in original) to be verified subsequently:-

- (i) Academic qualification(s) certificate.
- (ii) Matriculation/Date of Birth Certificate.
- (iii) Domicile Certificate issued by the competent authority.
- (iv) Health Certificate from the concerned Chief Medical Officer of the District.
- (v) Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- (vi) Dependent Certificate issued by the designated authority.
- (vii) All other relevant documents as are required under SRO-43/1994.

The appointment of the above candidates shall further be subject to the following conditions:

- (a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him.
- (b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of Qualification/Date of Birth is received from the concerned Authorities.

- (c) The appointee shall be initially on probation for a period of two years in accordance with the J&K Revenue (subordinate) Service Recruitment Rules, 2009.
- (d) The appointment of the candidate shall be governed in terms of "Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020" notified vide SO 192 of 2020 dated 17.06.2020.
- (e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (f) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed have been cancelled *ab-initio*, without any further notice.


